- 3. It was communicated that the constituent units of DWARKA group have to complete the Pre-selection trials before **December 2021** for participating in the Final selection trials. All possible efforts to be made and ensured that the Final selection trials of DWARKA group of each event has to be completed before **11.1.2022** so that the final list can be sent to DAE.
- 4. It was communicated that all the events will be held as per the guidelines issued by DAE S&C Council 2021-22 and keeping the Government Covid Guidelines into consideration. Ensure that all participants have taken second dose of vaccination. A copy of the guidelines issued by DAE S&CC has already been issued to all DWARKA Units.
- 5. The various units of Dwarka groups showed their dissatisfaction regarding not getting a chance for hosting the DAE final meet. In this regard, it was discussed at length & agreed upon that the individual unit of Dwarka group will send their willingness to host the final DAE meet to the Chairman, Dwarka Apex committee well in advance i.e. prior to the meeting of DAE S&CC. Chairman, DWARKA will request DAE Sports and Cultural Council to allot Final event to concerned DWARKA Unit as per choice.

- 6. The matter for deciding the venue for final selection trial of Dwarka group was discussed & there was eagerness to hold the final selection trial of particular events from more than one units & it became difficult to finalise the venue. Hence, a guideline is made & agreed upon by all the Dwarka units that first preference of conducting the final selection trial of particular event will be given to the unit who is going to host the final meet (DAE) of that event. This will help in developing sports infrastructure & readiness for the final event in the units.
- 7. After detailed discussion, the venue and dates for conducting final selection trials of the following events were finalized as mentioned below :-

- 8. The Units who are conducting the Final selection trials are advised not to change the dates as far as possible.
- 9. The Manager of the team will be decided by the Unit conducting the Final selection trials and the same will be intimated to the Leader Unit.
- 10. All the Units who conduct the Final selection trials will intimate the result to the Leader Unit immediately through mail.
- 11. Unit hosting the Final Selection Trials should book accommodation and also arrange for transportation to the outstation players.
- 12. Managers selected for Final Meet should submit the tour report to Unit co-ordinator of the respective participating players with a copy to the Leader Unit. It is also requested to intimate the results and trophy won, if any, to the Leader Unit for compiling the report on behalf of DWARKA group.

- 13. In the event of a player not able to go for the Final Tournament his/her Unit should convey this information to the following telephonically followed by mail.
- 14. It is important that Managers and players from all the Units should endeavor to select best players/team for DWARKA Group. It was informed to all the Units that every individual shall maintain discipline and exhibit excellence in Sportsmanship on and off the field. The Manager has to play a pivotal role in this respect. Hence, the choice of Manager must be done keeping this objective in mind.
